Subject: Grant of yearly Permission to Nizamia Unani Medical College & Hospital, Dumri, P.O. Rasalpur, Via-Buniyadganj Distt. Gaya-823003, Bihar (Inst. Id.: UNIO280) with 28 seats (instead of 40 seats) in UG (BUMS) course under section 28 of NCISM Act, 2020 for the academic session 2025-26-reg.

Sir/Madam,

- To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Nizamia Unani Medical College & Hospital, Dumri, P.O. Rasalpur, Via-Buniyadganj Distt. Gaya-823003, Bihar (Inst. Id.: UNIO280)** inspection was conducted on **02.05.2025 & 03.05.2025 via Hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process **annual visitation for issuance of permission with intake capacity of 40 seats in UG (BUMS) course under section 28 of NCISM Act, 2020 for the academic session 2025-26.**
- The visitation report and all other related documents were assessed in terms of enforced regulations namely the Minimum Essential Standards, Assessment and Rating for Undergraduate Unani colleges and Attached Teaching Hospitals Regulations, 2023", and provisions under the NCISM Act, 2020 and relevant regulations thereunder. **On careful examination of the assessment report and as per the Visitor Observation following shortcomings/defects have been observed:-**

A. Teaching staffs:-

- Arabic teacher is not available.
- Availability of total teaching staff for UG (BUMS). Course as per the part 1 submitted by the college is $\frac{\text{Available}}{\text{Required}} \times 100\% = \frac{27}{30} \times 100\% = 90\%$ (Excluding Excess).

F. Functionality of the hospital:-

- a) No. of OPD 8 available and **no OPD for Ilmu Samoom (Clinical Toxicology).**
- b) **OPD is not functional.**
- 3) Thereafter, the assessment report was duly placed in the **130th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 03.07.2025** and the Board decided to seek clarification from the college with regard to afore mentioned shortcoming/defects and the same was informed to you vide letter of even no. dated **04.08.2025**. In response of the same you have submitted the clarification vide letter ref. No. 252/NUMCH/25 dated **07.08.2025**.
- 4) Further, in view of the clarification submitted by you, the assessment report along with clarification was placed in the **143rd Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 26.08.2025** and Board decided that the college is not fulfilling the notified & requisite criteria for issuance of permission as per the Concerned Acts and regulations but fulfilling the criteria for issuance of Yearly Permission in accordance with the Board's policy letter issued on **23.01.2025**. Hence, the Board decided to issue Permission as per the approved Seat Reduction Policy in accordance of Section 28(1)(f) of NCISM Act 2020 as the college has not followed the AEBAS guidelines as mentioned in Implementation letters vide ref. no. **3/2024/MARB/AEBAS** and HMS dated **09.05.2024** and ref. no. **3/2024/MARB/AEBAS** and HMS dated **06.09.2024**.

As per the Penalization Policy adopted in accordance of Section 28(1)(f) of NCISM Act 2020 for Non/Improper/Delayed Implementation of Aadhaar Enabled Biometric Attendance System (AEBAS) in ASU College for the Academic year 2025-26:-

- a) "In cases of delayed or improper implementation of the Aadhaar Enabled Biometric Attendance System (AEBAS), the college shall subject to seat reduction by reducing 30% intake strength of total intake capacity."

Therefore, for seat reduction in the intake capacity shall be considered by reducing the intake strength by 30% of total intake capacity.

Hence, after applying the seat reduction policy 2025-26 under section 28(1)(f) of NCISM Act 2020 for **Non/Improper/Delayed Implementation of Aadhaar Enabled Biometric Attendance System (AEBAS) in ASU Colleges for the Academic year 2025-26**, the college is fulfilling the basic eligibility criteria for issuance of Yearly Permission with 28 seats (instead of 40 seats) in UG (BUMS) course.

"DECISION"

- 5) **Therefore, Nizamia Unani Medical College & Hospital, Dumri, P.O. Rasalpur, Via-Buniyadganj Distt. Gaya-823003, Bihar (Inst. Id.:- UNI0280) with 28 seats (instead of 40 seats) in UG (BUMS) course in accordance with 16 (2) & 16 (3)(h) of MESAR UG (Unani) 2023 & as per the approved seats reduction policy under section 28 of NCISM Act, 2020 and subject to the condition that the following requirements shall be fulfilled: -**
- I. **Minimum 15% of undergraduate seats of the permitted intake capacity with 28 seats (instead of 40 seats) shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction for all India quota or the students admitted thereunder.**
 - II. **Determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.**
- 6) **Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.**
- 7) **Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
- 8) **Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.**
- 9) **Compliance of all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters with vide ref. no. 3/2024/MARB/AEBAS & HMS dated 09.05.2024 & 06.09.2024 issued by the Board.**
- 10) **The following requirements must be fulfilled and the compliance report shall be submitted to the MARB-ISM by 31st December, 2025 to be considered for the process of issuance of permission for the academic session 2026-2027:-**
- i) **All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.**
 - ii) **All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduate Unani colleges and attached teaching hospitals) Regulations, 2023.**
 - iii) **All the requirements of the National Commission for the Indian System of Medicine (Minimum Standards of Undergraduate Unani Education) Regulations-2022.**
 - iv) **Shortcoming under Para 2.**
- 11) **The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for**

Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.

In case, if you are not satisfied with the above decision you may prefer 1st appeal to the Chairman/Secretary, NCISM as per relevant rules & regulations thereunder.
